ICoRSA's 2024 conference is co-organized by ANICT and NInTec in an hybrid format.

On **January 12**, ICORSA, ANICT and NInTec will hold a conference focused on **research precarity in Portugal**, **open to all interested participants**. It will start with a presentation of the OECD reports on precarity and pathways in research careers. A presentation by the European Commission will follow on the **European Framework for Research Careers**, the recent initiative under the ERA Policy, and on Member States recommendations. The Conference will end with a roundtable discussion on the recent reforms to address precarity in Portugal, as well as examples of best institutional practices by Portuguese Universities. The discussion will bring national and international experts, namely from Italy, Germany and Spain with particular examples of Tenure Programmes and an European context by the Chair of the high level group for the evaluation of Horizon Europe, Dr Manuel Heitor.
